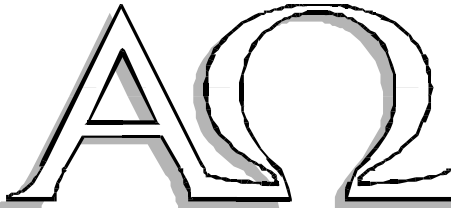

Today

Make no mistake; we are seeing a vast transfer of wealth scheme that has been centuries in the making. As even economist John Maynard Keynes has admitted, it is by continuing inflation that "government can confiscate secretly and unobserved, an important part of the wealth of its citizens."¹ Using the governments admitted inflation rate of 3-4%, it will only take 18 to 24 years for prices to double. A more realistic inflation rate would be 10-11%, which would result in a doubling of prices in approximately 7 years.²The government has told us that they have a surplus, and have balanced the budget. What they have not told you is that they "cooked the books" for public consumption. In order to show favorable numbers, they borrowed from the Social Security trust fund, and

declared it income rather than a loan. If, as they say, we have a balanced budget, how is it that the public debt is nearly \$18 billion more at the end of fiscal year 2000 compared to 1999?³ This is "smoke and mirrors" perpetrated on a gullible public! We are, in fact, facing serious economic problems. With an expected downturn in the economy we can surely expect a rise in unemployment. It is estimated that each 1% rise in unemployment adds \$60 to 80 billion to the deficit, due to increases in "entitlement" programs and loss of tax revenue as a result.

The Federal Reserve will continue to prop up the banking system by increasing the money supply (inflation). A tax cut on income may moderate the downturn by spurring economic growth and producing more tax revenue over the long term.⁴

We have a potential crisis in the making. We have an illusion of prosperity by an artificially sustained dollar. Our national debt exceeds the available money supply. We have been working with a monetary system that employs dishonest weights and measures.⁵ We need to wake up to the fact that the moneychangers are transferring the wealth of the world from the haves to the have-nots so that they can fulfill their dream of the feudalistic utopian society with them as the rulers. But more than that, we are a culture in crisis.

We are a Culture in Crisis

Jim Nelson Black, in his book, *When Nations Die*, describes ten warning signs of a culture in crisis, heralding the impending death of a nation. These ten signs are subdivided into three categories:

- A. Social Symptoms** — 1. Increase in lawlessness, 2. Loss of economic discipline and self-restraint, 3. Rising bureaucracy, government regulation, and taxes, and 4. Decline in the quality and relevance of education.
- B. Cultural Factors** — 5. Weakening of the foundational principles that contributed to the greatness of the nation, 6.

Loss of respect for established religions, and 7. Increase in materialism.

C. Spiritual Indicators — 8. Rise in immorality, 9. Lure of alien gods, and 10. Decline in the value of human life.⁶

We see in monuments left behind the evidence of the great civilizations of the past. A study of their decline shows that their culture experienced a loss of creative vitality and a fundamental shift from one belief system to another. This resulted in enormous social and political changes. Britain abandoned its moral and political heritage to pursue a socialist utopia. In America, Christians have failed to defend their beliefs at the first sign of resistance.⁷ Our moral leaders would rather be politically correct than politically anathema. Political correctness and a failure to take a moral stand contribute to the decline of our traditional values system, and a weakening of the nation. At some point we must choose to stand and fight for those values.

Compared with other nations in the industrialized world, the United States ranks near the top in rates of abortion, divorce, and births to unwed mothers. We lead in murder, rape, and violent crime. In elementary and secondary education, we are near the bottom in achievement scores. The “change agents” of our educational and information establishment are stripping this nation of its traditional values, and transforming this nation into their ideal of a utopian socialist state. Dr. Allan Bloom (*The Closing Of The American Mind*) believes that American high school graduates are among the most “sensitive illiterates” in the world. When compared with students of other nations, our students consistently place near the bottom in every academic category. They are incredibly sensitive, environmentally aware, but pathetically ignorant.⁸

Civilization arises from religion. Whenever a nation becomes confused, and loses its faith in its traditional belief system, whether pagan or Christian, that nation begins to decline. This was true of Greece and Rome, and it is true of this nation. The multiculturalism and humanism promoted for the sake of tolerance is confusing and destroying the core values that once made America great.⁹ Many of our Christian leaders fail to take a public stand concerning the hard issues, further weakening the Christian position in the public debate. Many would rather be politically correct and popular, rather than lose their public forum over righteous stands. Many tailor their pronouncements in support of a growing ecumenism involving all religions, gaining establishment media approval.

The universities of this nation have divorced morality in favor of personal choice. Under this new morality of personal choice falls the responsibility of the government to maintain correct attitudes and behavior. The state demands absolute control as it administers its welfare, creating ever more dependency on government. The people elect government leaders who will continue this cycle of handout and dependence, thus creating a form of modern serfdom. Full blown, the welfare state can allow no interference. The insistence on the separation of church and state is a result of the tension and competition with the welfare state. In

order to maintain the state's domination of society, our court and tax systems have effectively barred the clergy from the arenas of public debate.¹⁰

We are now in a society that is gradually reinterpreting our traditional values toward a modern social code of moral relativism. We are being taught, and otherwise led to believe, that our cultural traditions were flawed from the start, and our nation's achievements and former glory were myth and lies. Our children are being taught that Western culture is exploitative and imperialistic by nature. Our supposed traditional moral values were nothing more than hypocrisy, which resulted in social exploitation, misogyny, and greed. Western values, we are told, interfere with the richness and diversity of the planet. We undermine the legacy of our Founding Fathers; and we are offered instead, “a new concept for a new age—a global ecological sensitivity, a radiant vision of a new world order, and a radical political system only waiting to be born. All of this represents a concerted effort to change the world through various kinds of ‘expert systems’ being devised by the elites in government, the judicial system, higher education, and the media.” Our system is being “dismantled and revised by liberal dreamers with visions of a man-made utopia.”¹¹

We have gravitated away from our traditional safeguards of self-control, deferred gratification, fear of detection, and fear of God; and replaced them with “evolving standards of decency.” This is exactly how Supreme Court Justice Sandra Day O'Connor described it when she embraced “evolving standards of decency that mark the progress of a maturing society.” In other words, the law is what the court says it is, not the checks and balances of an absolute rule of our Constitution.¹² If the Constitution can be reinterpreted and redefined by our courts, then where are the safeguards for the individual and our society? Judicial relativism and social evolution is redefining our society. Our judges are doing what is right in their own eyes, by their standards.

Today, our society is being restructured by “liberal opinion”—that is, the popularization of attitudes and policies controlled by sentiment rather than sound moral judgment.” To understand the political ideology known as liberalism, we need to understand that it is “a philosophy dedicated to overthrowing the status quo. The liberal worldview that first came into being during the Enlightenment placed man rather than God at the center of the universe.” I had an uncle, a former university professor, who was of the same mind. In discussions with him, it was clear to see that he mistook “feeling” for moral judgment, and he truly thought that man, with the help of government, could solve his problems by social planning and rational action. His sympathies were with the underprivileged and hurting, and that culture must change to benefit even the smallest of minorities. The truth is, as society disintegrates around us, citizens demand solutions from liberal government, but the politician's solution is to apply more liberal laws, further eroding our freedoms. The real solution should be more checks and balances, restraints on judicial practice, realistic justice in our courts, swift and certain justice for criminals, keep hardened

criminals behind bars, a strict interpretation of the Constitution, and most of all a return to our foundational traditional values.¹³

Alexis de Tocqueville, a Frenchman, visited America in 1820, and wrote in *Democracy in America* that he feared that the downfall of our nation might come about by a slow, almost imperceptible degradation of the people towards eventual despotism, through an equally slow and imperceptible deterioration of morals, national polity, and an increase in the size of government at the expense of our freedoms and form of government, until finally, the despots would gain totalitarian control over our lives.¹⁴

This newsletter issue concerns the steps of the final stage of our decline, when all freedoms are lost, and like a Phoenix rising from the ashes, we see instead of the Phoenix, a fiery red dragon; and for those that remain, all hope is lost.

Part 4

Educating For The New World Order

Babylonian New World Order

In the third year of the reign of Jehoiakim king of Judah came Nebuchadnezzar king of Babylon unto Jerusalem, and besieged it. Daniel 1:1

And now have I given all these lands into the hand of Nebuchadnezzar... my servant... And it shall come to pass, that the nation and kingdom which will not serve the same Nebuchadnezzar the king of Babylon, and that will not put their neck under the yoke of the king of Babylon, that nation will I punish... Jeremiah 27:6, 8.

Jerusalem shall be trodden down of the Gentiles, until the times of the Gentiles be fulfilled. Luke 21:24.

And the Gentiles shall come to thy light. Isaiah 60:3.

The prophet Jeremiah prophesied that Nebuchadnezzar (King of Babylon from 605-562 BC) was to establish a new world order by God's decree:¹ Nebuchadnezzar's Babylon was the first of the Gentile nations that figured in God's plan of the "times of the Gentiles."² **The "times of the Gentiles" beginning with Nebuchadnezzar will not end for Jerusalem until the Lord returns to fight the assembled nations at His Second Advent.**³ God's plan was that all people, Jew and Gentile, would be given the opportunity to be saved, and Nebuchadnezzar would play his part in that plan.

Captivity and Tribulation

At the end of King Solomon's reign, 975 BC, a revolution caused by religious apostasy and excessive taxation split Israel into two parts - Israel was composed of ten tribes, and Judah was composed of Judah and Benjamin.⁴ The Northern Kingdom apostatized more than Judah and both went through 300 years of civil strife until finally Assyria conquered the northern ten tribes and carried thousands into captivity to Nineveh. A remnant escaped into Judah.⁵ The Assyrians sent aliens into Israel (Northern Kingdom) to mix with the remaining people, to further assure the destruction of the country and people.⁶

After conquering the Northern Kingdom, the Assyrians next turned their sights on Judah. They pushed south to Judah, but by the intervention of God the Assyrians were defeated and Judah was preserved.⁷ Judah, instead of repenting and keeping the laws of God, entered into apostasy and rebellion. Therefore, God withheld his protection, and 100 years later the Babylonian Empire, after absorbing the Assyrian Empire, came against Judah and conquered Jerusalem.⁸

Jehoiakim, the king of Judah, was morally corrupt and unsympathetic to the condition of his people. He encouraged the worshipping of idols. He tried at first to deal with Nebuchadnezzar, but after having delivered Jerusalem to Nebuchadnezzar, reneged and attacked the Babylonians. He was slain by Nebuchadnezzar and his body left to rot outside the gates of Jerusalem.⁹ Both Isaiah and Jeremiah prophesied the fall of Judah.¹⁰

And this whole land shall be a desolation, and an astonishment; and **these nations shall serve the king of Babylon seventy years.** Jeremiah 25:11.

Daniel reports the event:

And the Lord gave Jehoiakim king of Judah into his hand, with part of the vessels of the house of God: which he carried into the land of Shinar to the house of his god; and he brought the vessels into the treasure house of his god. Daniel 1:2

During this time, Solomon's Temple was profaned with idols, after which it was completely destroyed.¹¹

It is in this setting in which we are introduced to a young man named Daniel, who is about to be educated for a new world order.

And the king spake unto Ashpenaz the master of his eunuchs, that he should bring certain of the children of Israel, and of the king's seed, and of the princes; Children in whom was no blemish, but well favoured, and skilful in all wisdom, and cunning in knowledge, and understanding science, and such as had ability in them to stand in the king's palace, and whom they might teach the learning and the tongue of the Chaldeans. Daniel 1:3, 4.

The words of the above verses, "of the king's seed and of the princes," indicate that these children were the elite of Israel.¹² The Babylon of Nebuchadnezzar had a worldview, or belief system. Daniel and his friends were about to be educated for Nebuchadnezzar's new world order. The usual education of youths began as early as age 14. The words used may imply that they were between 15 years and 20 years of age.¹³ It's also possible that they could be as young as 12 years according to the word used for children.¹⁴ The use of the word "Chaldeans" indicates that they were to be of the class called Magi.¹⁵ Those that would have world government today know that they must capture the minds of the nation's children.

Restructuring Education for the New World Order

According to Lynn Standley, "On 31 March 1994, the Goals 2000: Educate America Act became law. The law will impact all 15,700 school districts and has been labeled a 'massively intrusive bureaucratic nightmare.'"¹⁶ In her book, *Combat Ready: How to Fight the Culture War*, Lynn Standley writes this description of the U.S. government program, Goals 2000:

Goals 2000 will invade every American home through mandatory Outcome-Based Education, and all the violations of personal privacy that implies. Further, government will keep detailed dossiers on every American child, *from the day he is born*.... That information will be stored in the Elementary and Secondary Integrated Data System, enabling the state to keep a cumulative record of your child until the day he dies.... Government calls Goals 2000 a "lifelong learning" plan, but Bill Clinton... referred to the essential role of the states as "laboratories of democracy" and gave his opinion that the education of our children "is and always has been a State responsibility."... In making Goals 2000 law, government seized every parent's power to make decisions regarding education reform and gave it to the state.... Goals 2000 is designed to manipulate thought and de-emphasize the cognitive skills needed to learn reading, writing, and math... using... behavioral-

adjustment techniques to restructure society and will use Goals 2000 curriculum to indoctrinate children in an effort to subordinate them to government. The intent of Goals 2000 is to shift allegiance from family and country and redirect it toward global citizenship and one world government.... Under the guise of national educational reform, Goals 2000 aspires to completely "restructure society."¹⁷

Berit Kjos describes Goals 2000's Outcome Based Education (OBE), renamed Mastery Learning (the names change, but its still OBE):

The strategy for resocializing our children is best known as Mastery Learning.... It refers not to solid factual learning but to the psychological process of conditioning students to new-paradigm thinking. It is based on the behavior modification formulas of B. F. Skinner, who said "Operant conditioning shapes behavior as a sculptor shapes a lump of clay," and "I could make a pigeon a high achiever by reinforcing it on a proper schedule."... Globalist educators [are] determined to mold our children into a compliant workforce for a new global society by year 2000... Socialization—the "right" attitudes, beliefs, and behavior—[has] replaced academics as the main outcome of education. In spite of the nice-sounding promises, individualism [is] out, and group thinking and universal values were in. The minds of children were being molded through the latest techniques in behavioral psychology.... [T]he strategies for molding the global workforce stress mental and emotional "health," not factual learning.... Outcome-Based Education, or OBE, is also called Quality Learning, Total Quality School Restructuring, Performance- or Achievement-based Education.... Whatever the label, it refers primarily to the national/international system that demands specific "outcomes" from students and uses psychological strategies of Mastery Learning to achieve the planned result.¹⁸

Goals 2000 and America 2000 are virtually the same government programs. They are programs designed to restructure American Education using "behaviorist attitude restructuring techniques to move American citizens from a position of loyalty and allegiance to the United States to identification as planetary citizens." The America 2000 plan was revealed to the public early in 1991, but was renamed Goals 2000 by the Clinton Administration. Ann Herzer, one of America's foremost researchers of the educational restructure program discusses restructuring education for the New World Order and the destruction of the free enterprise system:¹⁹

The goals and objectives from every state regarding America 2000 are the same, i.e. restructuring

education. The intent in every state is identical. The total restructuring of society is to take place under the umbrella of the local school. The federal government, with the help of the major tax-free foundations and the New American School Development Corporation (with their hand-picked Design Teams) intends to control all aspects of American society from pre-conception to death.... The purpose of restructuring American education was to put in the Asian/European system of education which selects small children at a very early age to meet the needs of the planned economy. In order to accomplish this goal, the families and total community must be brainwashed into turning children over to the government.²⁰

To believe that such massive functional illiteracy is an unplanned phenomenon beyond the control of anyone is to believe that our educators with all of their doctoral degrees literally don't know what they are doing.

Samuel L. Blumenfeld, in his 1984 book, N. E. A.: Trojan Horse In American Education

In our new world order we need to mold "global citizens." One of the three major goals of, the 1967, *The Behavioral Teacher Education Project* calls for the "development of a new kind of **elementary school teacher** who... engages in teaching as clinical practice... and **functions as a responsible agent of social change.**"²¹ Is it not comforting to know that your children are being educated by "a responsible agent of social change?"

Implementation in all states is intended to mandate that all 10th grade students pass a test to obtain a "Certificate of Initial Mastery." This would make it illegal for employers to hire anyone without this certificate. Any student failing to pass will be sent to Learning Centers to monitor their intensity. At this point, "students will be tracked into either a vocational or professional career." This system has been introduced in different states under different guises. The idea is to create a nationalized workforce.²² In regards to creating a nationalized workforce, anyone familiar with the elements of Total Quality Management (TQM) will recognize that a similar system, with international standards, has been implemented in the workplace of many companies throughout the world, in effect "cloning" the worker.

Implementing the Plan

Nebuchadnezzar's dream of the tree in Daniel chapter 4 indicated that Nebuchadnezzar planned to re-institute Nimrod's original one-world plan. He brought together the best and brightest from the foreign cultures he conquered. He educated them in one language to bring together all knowledge and talent under Babylonian control.²³ The melting pot of the United States has accomplished the same thing. The various talents and knowledge inherent in the individual races are brought together under one tongue to produce the greatness that is America.²⁴

Nimrod built Babylon to challenge God by a united

mankind. Nebuchadnezzar sought to challenge God by bringing together all knowledge. The nations today are coming together to challenge God once more. We are to have a global society where we will be world citizens governed by a world government. Today's nations are reviving the Babylonian system. This final Babylon will be destroyed in a single hour, according to the book of Revelation:

Babylon the great is fallen, is fallen, and is become the habitation of devils... that great city Babylon, that mighty city! for in one hour is thy judgment come... for in one hour is she made desolate.... by thy sorceries were all nations deceived....

Revelation 18:2, 10, 19, 23.

It is interesting that the European Union has adapted a modern version of

the Tower of Babel as a symbol of European unity. A woman riding a beast is also depicted on European coins. Is it a coincidence that this same image of the "harlot" on a beast is described in Revelation chapter 17? In New York City stands a modern "Tower of Babel," the United Nations, in which the world attempts to be one voice. Nimrod's original Babylonian religious system, founded before the Tower of Babel, has infected all cultures and religions of the world, and the last day's religion will revert back, as the various religions compromise their doctrines and meld into a one-world religion, to complement the one-world New World Order.

Seduction

And the king appointed them a daily provision of **the king's meat, and of the wine which he drank:** so nourishing them three years, that at the end thereof they might stand before the king.

Daniel 1:5

This was a plan for seduction and brainwashing. They were to remain Jews but to be Babylonian in their thinking.²⁵ We are doing the same today with our children in our public school systems as Hitler did with the "Hitler youth." Hitler didn't need the old, he had already persuaded the children. This is our modern-day Goals 2000. The world system seeks open-mindedness, our young are made to believe that everything is relative - there are no absolutes. Once they believe this, they can be molded to believe anything the world system desires.²⁶ This is the purpose of Goals 2000, to restructure society with willing workers. According to Allan Bloom, "Truth is relative" is the mantra that the public school for the past fifty years has been promoting diligently:

There is one thing a professor can be absolutely certain of: almost every student entering the university believes, or says he believes, that truth is relative.... Relativism is necessary to open-mindedness; and this is the virtue, the only virtue, which all primary education for more than fifty years has dedicated itself to inculcating. Openness—and the relativism that makes it the only plausible stance in the face of various claims to truth and various ways of life and kinds of human beings—is the great insight of our times. The true believer is the real danger.... The study of history and of culture teaches that all the world was mad in the past; men always thought they were right, and that led to wars, persecutions, slavery, xenophobia, racism and chauvinism. The point is not to correct the mistakes and really be right; rather it is not to think you are right at all.²⁷

The education system is **dedicated** to teaching that “truth is relative.” If truth is relative, then there are no absolutes. If there are no absolutes, then there is no basis for law. Then the Constitution and the Ten Commandments are nothing more than suggestions. Jim Nelson Black believes:

The shocking state of education today is directly attributable to the social agendas being force-fed to teachers and pupils alike in the nation’s public schools. Educators today no longer concentrate on the standard curricula of previous generations. Classical learning has been turned on its head in favor of the socially expedient. And instead of educating students in subjects that build moral character and civic virtues, today’s textbooks program children with the agenda of the Left....²⁸

By the 1980’s and 90’s, the biggest concern of educators was not safety, but the implementation of programs such as “values clarification” and “value neutral thinking.” Instead of the three R’s, we find that the three S’s, “sensitivity,” “self-esteem,” and “safe sex,” achieved the greatest attention.²⁹ According to Samuel L. Blumenfeld, in his 1984 book, *N.E.A.: Trojan Horse In American Education*, there were at that time:

24 million functional illiterates in the United States, **virtually all of whom have had from eight to twelve years of compulsory public schooling.**³⁰

Black indicates the number of functional illiterates increased to 28 million by 1994.³¹ Blumenfeld further indicates that this was a result of a change in teaching methods after 1930. He goes on to say that “functional illiteracy” was a planned outcome of their method, because it was their belief that high literacy is an obstacle to socialism.

To believe that such massive functional illiteracy

is an unplanned phenomenon beyond the control of anyone is to believe that our educators with all of their doctoral degrees literally don’t know what they are doing.³²

It was John Dewey [the father of progressive education] who first formulated the notion that high literacy is an obstacle to socialism.... Dewey knew that the new teaching methods would not produce better readers. He assumed that their reading would improve “later.” Incredible as it may seem, for Dewey the social goals justified the use of these new teaching instruction methods.³³

The reason that high literacy is undesirable to Dewey and others in the New World Order crowd is that literacy fosters independent thinking, gives the students the means to seek knowledge independently, thus inhibiting the establishment of a new socialist order.³⁴ Independent thinking by the worker bees is anathema to the planners of the New World Order. According to William J. Bennett:

Many of the elite correctly understood that civilization’s major task is the upbringing of children; if they could alter the ways we raised children by changing the way we teach them, they could then alter our American society to suit their view of the world.³⁵

Preparing the world for the global world order begins in the school system. UCLA professor Walker Bush indicates that

[T]he long-term goal of the World Order Program at UCLA is to provide an introductory course in globalist thinking to every entering student. Their aim is, in short, to refocus the entire ethos of higher education. In addition, the University will offer upper-level degrees in various global issues in order to turnout cadre of new-world-order scholars and strategists.³⁶

Pat Robertson agrees that this is the plan, and indicates that we are heading toward a system where freedom will be lost.

Education of the young to a new way of thinking must begin in the academy: teaching teachers who teach students who, in turn, grow into predictable products of the system. It is the conviction of these world-order advocates that subtle, patient, and gradual changes in education, shaping the minds of the youth of our democratic nations, will bring the real victory of the new world order.³⁷

[Higher education has changed and is now] heading toward a system where one has no freedom at all, accept the freedom to accept the politically correct

doctrines of the current fad.³⁸

Chuck Colson and Jack Eckerd write:

Education, that had for centuries formed character along with imparting knowledge, now became a “value-free” instrument of social therapy and experimentation that institutionalized the freewheeling lifestyle of the sixties. Sidney Simon of the University of Massachusetts, chief promoter of the ubiquitous “values clarification,” believed that teaching values to children was a form of brainwashing.³⁹

Our education systems have a purpose. Everyone has a worldview. Ask yourself, what is the worldview of the modern education establishment?

Modern Day Babylonian Belief System

Just as in Daniel’s day, there is a “Babylonian” belief system at work in this nation. It consists of four parts and is responsible for the mindset, or worldview, of the people educated in our society today. These four parts consist of **Humanism, Existentialism, Pragmatism, and New Age Mysticism**.⁴⁰ Each one reinforces in the minds of our children that truth is relative and that everything we desire is right for us (self gratification). And, we are instructed not to impose our belief system on others.

Humanism

Essentially, Secular Humanism says that: (1) There is no God; man is the measure of all things; (2) Man is basically good; (3) Whatever man desires is right for him; (4) Education is about learning to live in a world where God either does not exist or is irrelevant; and, (5) Laws need not conform to any higher standard than what men of the moment desire.⁴¹

The following is an outline of the humanist’s philosophy as found in their bibles, *HUMANIST MANIFESTOS I AND II* (written in 1933 and 1973)⁴² For an enlightening exercise compare this humanist philosophy with the philosophy of Karl Marx as he describes it in *THE COMMUNIST MANIFESTO*.⁴³ The philosophies are nearly the same. The elements of humanistic philosophy are:

Evolution - There is no real evidence that God exists. The universe is the result of chance. Life forms gradually emerged over millions of years.

Situation Ethics - Man is the final authority for his own actions. There are no absolute rules.

Moral Freedom - Everyone (including children of any age) should be exposed to all viewpoints that are “realistic,” including profanity, immorality, and perversion — all seen as acceptable methods of self-expression. The Christian gospel is not realistic, so has no place in the system.

Self-Sufficiency - Man is not accountable to any higher power. He is responsible to himself.

Sexual Permissiveness - All forms of sexual expression

are acceptable and should be taught in schools free from biblical bias.

Anti-religious Bias - Religion is harmful. It is either meaningless or irrelevant to the question of the survival and fulfillment of the human race.

Socialism - Government ownership or control of the economy should replace private enterprise and private ownership of property. There should be an all-pervasive welfare state.

One World Government - “Global citizenship” should replace national self determination. There should be a system of world law, enforced by an international police force transcending national federal government.

Death Education - There is no life beyond the grave. Euthanasia should be employed and suicide endorsed as acceptable ways to terminate life.

Human Destiny - Man should take charge of his own future and realize that he has within himself the power to achieve the world of his dreams.⁴⁴

Since socialism is the preferred form of government of the humanists, we list the tenets of communism, since communism is, in reality, extreme socialism:

- Abolition of private property.
- Heavy progressive or graduated income tax.
- Abolition of the right of inheritance.
- Government confiscation of property.
- National banking system (central bank, e.g. The Federal Reserve).
- Communication and transportation under control of state.
- Instruments of production owned by the state.
- Forced labor.
- Population control.
- Free education in public schools.⁴⁵

How many of these, either Secular Humanism or Communism, do you recognize in our own country. In addition to the ten main tenets of communism listed above, Karl Marx desired to abolish the family, abolish countries and nationalities, abolish eternal truths (freedom, justice, religion), and abolish morality.⁴⁶ We will further expand on Secular Humanism in Part 5.

Existentialism

Both Sartre and Nietzsche viewed life as meaningless. “Having rejected God, and finding no cause worthy of total commitment, they move to the utopian ideal of the Marxist world view, gathering the herd under their ‘superman wings.’”⁴⁷ To the existentialist, life is viewed as follows: (1) Life is meaningless; (2) Life is a system of choices. The existentialist is one that is “pro choice;” (3) Immorality is defined as anything that hinders your act of choosing what you desire. Morality is personal; (4) “Law,” or “Constitution,” becomes meaningless. Our only standards are those we choose at the moment; (5) Education is about becoming true to yourself; (6) Decision-making skills teach only a process of exploring and affirming choices; (7) The

existentialist is alienated from his neighbor because everyone threatens his freedom to choose.⁴⁸ Hitler used Nietzsche's ideas and "drove the atheistic world view to its legitimate conclusion."⁴⁹ This is best described in Hitler's words:

I freed Germany from the stupid and degrading fallacies of conscience and morality... we will train young people before whom the world will tremble. I want young people capable of violence—imperious, relentless and cruel.⁵⁰

Pragmatism

Pragmatism can be summed up in the following: (1) If truth is not practical it serves no purpose; (2) Education to the pragmatist is learning to do, not think. It emphasizes training, not insight; (3) Education is viewed by the state as a tool to produce more productive workers. State desired "outcomes" become important. (4) In the judicial system pragmatic judges are tempted to rule so as to gain the desired outcome, creating new law rather than applying the law.⁵¹

John Dewey, the father of modern progressive education, taught that learning comes through doing. Physical and emotional experience was valued over facts and practical knowledge. This type of learning leads to denial of importance of history and tradition, rejecting existing cultural and moral values in favor of "diversity" and "tolerance." According to Jim Nelson Black:

The theories of modern education can be summed up as a basic denial of the value of Western tradition and a repudiation of the role of religion in the welfare of the community.⁵²

Dewey, using the theories of Horace Mann, helped to promote compulsory education, which would become essential for the social indoctrination of the youth. Dewey's goal was to socialize the youth, and "transform them into creatures of the state." Those on the left use the tool of compulsory education to accomplish their social goals.⁵³

New Age Mysticism

The last part of the modern worldview is New Age Mysticism. New Age Mysticism can be described as: (1) New Age Mysticism is a spiritual philosophy derived from Humanism and mystical religious ideas of Eastern religions; (2) New Age Mysticism is the humanist's attempt at spirituality; (3) Man is no longer basically good, he is basically god; (4) Education is about re-owning our godlikeness - finding the truth within ourselves; (5) The teacher no longer teaches but facilitates student self-discovery; (6) The student no longer learns but intuitively senses what is right; (7) God is a cosmic force that requires no obedience, no worship, and no humility.

This is the perfect god for the me-generation.⁵⁴

Building the System

The modern Tower of Babel is in an advanced stage of construction. We need to be alert so that our children will not get caught in the mindset of the worldviews that oppose Biblical Christianity. Jesus Christ is coming soon. Watch! Be aware. Don't lose heart. We will explore the final steps to the utopian world in the next article. AΩ

Part 5

Steps to the Utopian World

And he causeth all, both small and great, rich and poor, free and bond, to receive a mark in their right hand, or in their foreheads: And that no man might buy or sell, save he that had the mark, or the name of the beast, or the number of his name.

Revelation 13:16, 17

We shall have world government whether or not you like it — by conquest or consent.¹

James Warburg in United States Senate Committee

Today the moneychanger is still at his table in the temple, but today the temple has changed. The hallowed halls of the world's central banks is where he resides, still spinning gold from straw. With this fake gold a new world order is being forged that will see the world merged into one. All this is being accomplished before our very eyes, but most of us are unaware of the chains that are being forged to bind our lives to a modern feudalistic society. How is this being done? The following briefly outlines some of the major steps along the way.

Education and the Media

Nebuchadnezzar educated Israel's brightest youths.

Our schools and the media condition our minds. The road to Utopia is made smooth by conditioning the masses to accept the idea of a one-world system. Much of the change in worldview is **due to conditioning in the public school and media arena**. The first stage of influencing the masses begins in the arena of education. The first step is to train the teachers, then influence the minds of the children. Samuel Blumenfeld in *NEA: The Trojan Horse of American Education* writes:

The road to humanist curriculum [*in the public schools*] began in 1918 with the NEA's² Seven Cardinal Principles which stressed humanist ethical values to replace those of traditional religion. The expulsion of the Bible from the public school did not occur all at once.³

The philosophy of Secular Humanism is Godless, and promotes the belief that man should be free to choose what is right for him without restraint, providing that his choice does not harm others. Humanism promotes the godhood of man. Socialism is the preferred form of government; ultimately leading to a socialistic one-world government.⁴ The nation's colleges and universities are full of teachers spouting humanistic thought in one form or another. Tim LaHaye in *The Battle For the Public Schools* quotes Samuel Blumenfeld:

The takeover of Harvard in 1805 by the Unitarians is probably the most important intellectual event in American history—at least from the standpoint of education. The circumstances that signaled the takeover were the election of liberal theologian Henry Ware as Hollis Professor of Divinity and the subsequent retreat of the Calvinists to a new seminary at Andover. From then on Harvard became the Unitarian Vatican, so to speak, dispensing a religious and secular liberalism that was to have profound and enduring effects on the evolution of American cultural, moral, and social values. It was, in effect, the beginning of the long journey to the secular humanist world view that now dominates American culture."⁵

Secular Humanists have gone to great pains to codify their ideas into "Manifestos."⁶ Some very well known influential individuals have signed these documents. If they have gone to so much effort, don't you think they intend to implement them? Much of the thinking that you get from the media is influenced by these views. In order to accomplish their plan, secular humanists have gravitated to four major fields over a period of three centuries, and in this order: **1. Education** — from day-care centers to graduate schools; **2. Government** — the promotion of anti-moral legislation; **3. Law** — the best professional springboard to politics, but also a controlling influence over the judicial system; and **4. Media** — the most effective way to communicate their ideology to the masses as: **a.**

Journalists, b. Writers, c. Publishers, and d. TV and radio owners, producers, script and screen writers, directors, actors, newscasters and talk-show hosts.⁷

The plan of the Secular Humanists is to secularize society. Their strategy is to: **First** — Take over the colleges and universities, turning them into religious citadels for the teaching of the religion of humanism while excluding or ridiculing the teachings of traditional religions based on the Bible; **Second** — Train the next generation of journalists, lawyers, politicians, educators and other molders of “public opinion;” and **Third** — Get former students now in government to pass laws and regulations favorable to humanist causes and vote them large amounts of money collected from taxes to support their work.⁸ It should be noted that there are two additional steps necessary for complete totalitarian control of the world. These two additional steps are control of banking and the military. Those steps are well under way.⁹ The humanist strategy of influencing the masses includes a controlled media. David Noebel in his book *Understanding the Times* has said:

America’s colleges and universities are not the only areas of Secular Humanist influence, however. The mass media continually publish and broadcast the Humanist worldview. The 1990 Humanist of the Year was Ted Turner, chief executive officer of Turner Broadcasting System, which now owns TBS Superstation, CNN, CNN Headline News, and Turner Network Television (TNT). In 1985 Turner founded the Better World Society; presently he is willing to present \$500,000 to anyone able to invent a new worldview suitable for the new, peaceful earth. According to Turner, Christianity is a “religion for losers”... and maintains that the Ten Commandments are “out of date.”¹⁰

A study done at Florida State University and published in a book titled *Who’s Running America*, states: “Television tells Americans what to feel as well as what to think about.”¹¹ This same study found:

In reality, political issues do not just “happen.” Creating an issue, dramatizing it, calling attention to it, and pressuring government to do something about it are important political tactics of agenda-setting. These tactics are employed by influential individuals, organized interest groups, political candidates, government leaders, and most of all, by the mass media.... Newspeople decide what the news will be, how it will be presented, and how it will be interpreted. As David Brinkley explained, “News is what I say it is. It’s something worth knowing by my standards.”¹²

And just what are those “standards?” The Florida State Study Found:

It is true that the nation’s media elite is the most

liberal of the nation’s elite groups.... When TV newscasters insist that they are impartial, objective, and unbiased, they may sincerely believe that they are, because in the world in which they live—the New York and Washington world of newspeople, writers, intellectuals, artists—the established liberal point of view has been so uniformly voiced.¹³

If you do not seek out news sources with alternate worldviews you will be knowledgeable about only one side of an issue. In effect, your ideas will have been manipulated. We might well ask why the Christian has not noticed the root problem; or if he has noticed it, why he has not done anything about it? Dr. Francis Schaeffer wrote in his 1981 book, *A Christian Manifesto*:

The basic problem of the Christians in this country in the last eighty years or so, in regard to society and in regard to government, is that they have seen things in bits and pieces instead of totals.

They have very gradually become disturbed over permissiveness, pornography, the public schools, the breakdown of the family, and finally abortion. But they have not seen this as a totality—each thing being a part, a symptom, of a much larger problem. They have failed to see that all of this has come about due to a shift in world view—that is, through a fundamental change in the overall way people think and view the world and life as a whole. This shift has been away from a world view that was at least vaguely Christian in people’s memory (even if they were not individually Christian) toward something completely different—toward a world view based upon the idea that the final reality is impersonal matter or energy shaped into its present form by impersonal chance. They have not seen that this world view has taken the place of the one that had previously dominated Northern European culture, including the United States, which was at least Christian in memory, even if the individuals were not individually Christian.

Related to this, it seems to me, is the fact that many Christians do not mean what I mean when I say Christianity is true, or Truth. They are Christians and they believe in, let us say, the truth of creation, the truth of the virgin birth, the truth of Christ’s miracles, Christ’s substitutionary death, and His coming again. But they stop there with these and other individual truths.

When I say Christianity is true I mean it is true to total reality—the total of what is, beginning with the central reality, the objective existence of the personal-infinite God. Christianity is not just a series of truths but Truth-Truth about all of reality. And the holding to that truth intellectually—and in some poor way living upon that Truth, the Truth of what is—brings forth not only certain personal results, but also governmental and legal results.¹⁴

We must renew our minds to the nature of our real enemy, and to the fundamentals of our faith, returning completely to the Biblical Christian Worldview. To pull off the one-world plan, those known collectively as “the establishment” have promoted the philosophies of both Secular Humanism and Communism as the officially sanctioned, politically correct worldview. If you flinch at the idea that communism is promoted, remember that it need not be labeled communism to be communism—these people are good at changing labels to further their worldview. Liberalism is Socialism.

The Establishment

You will certainly be comforted to learn that according to columnist Edith Kermit Roosevelt, granddaughter of President Theodore Roosevelt:

The word “Establishment” is a general term for the power elite in international finance, business, the professions and government, largely from the northeast, who wield most of the power regardless of who is in the White House.

Most people are unaware of the existence of this “legitimate Mafia.” Yet the power of the Establishment makes itself felt from the professor who seeks a foundation grant, to the candidate for a cabinet post or State Department job. It affects the nation’s policies in almost every area.¹⁵

The American Establishment generally consists of sons of old line families. They normally attend Ivy League schools such as Harvard or Yale. They may belong to exclusive secret fraternities such as Yale’s *Skull & Bones*. Many attend Oxford University as Rhodes Scholars. They gravitate to Wall Street, joining prestigious banking, brokerage, and law firms. They are seated on the boards of the tax-exempt foundations and corporations. From there some choose to enter public service, attaining high positions in the federal government. The prerequisite for the latter road is membership in the secretive Council on Foreign Relations. Emulating his father, Prescott Bush, President George Bush is a member *Skull and Bones*, as well as a CFR director.¹⁶ Our current president, George W. Bush, also became a member of *Skull and Bones* while attending Yale University.¹⁷

To illustrate the power and influence of one of the insider organizations on world events, we present Guaranty Trust Company and Brown Brothers, Harriman, each of which consisted of a long line of partners that were members of the order of *Skull & Bones*. Those members included, among others, W. Averill Harriman partner in both companies, and Prescott Bush (former President George Bush’s father) partner in Brown Brother, Harriman. It can be demonstrated that members of the order participated in creation of global conflict by their nearly simultaneous financial support of Marxist Russia and Nazi Germany from their inception. Also in existence is a letter from a member of the order, Thomas D.

Thacher, member of the Wall Street law firm of Simpson, Thacher & Bartlett, which summarizes intentions for the 1917 Bolshevik Revolution. This letter urges military assistance for the Soviet Army and intervention to keep Japan out of Siberia until the Bolsheviks could take over.¹⁸

The Council on Foreign Relations (CFR) has been the Establishment’s chief link to the U.S. government since its founding in 1921. The CFR advocates the creation of a world government and is soft on communism and socialism.¹⁹ Although most Americans have probably never heard of this organization, the membership reads like a “Who’s Who” of our nation’s leaders, educators, financiers, and members of the media. The media is conspicuous in its silence concerning activities and members of this extremely influential organization. If you examine a list of its members you will understand why they are silent - they all belong to the same club. The CFR virtually controls the U.S. Department of State and the Central Intelligence Agency (CIA) through its membership.²⁰ In addition, the membership of the CFR is filled with members in key areas of influence and control of the media, banking, education, politics, government, military, and industry.²¹ The CFR is the American counterpart of the “Round Table Groups” set up by Cecil Rhodes, together with his Rhodes Scholarships to promote the same goals of world federation, especially of an Anglo-American federation.²²

Two Wars

World War I presented the opportunity for the world planners to begin to fulfill their goal of world government. The Wilson Administration promoted America’s membership in the newly formed League of Nations. They could not, however, persuade Congress, so world government was stillborn at its founding.

World War II was quite another matter. Before the end of the war, the stage was being set for another try at world government. Finally, on 26 July 1945, the United Nations was founded in San Francisco. This time there was virtually no opposition from Congress. The United Nations was the culmination of years of planning, particularly by the CFR.²³

There are those that believe that both world wars were planned by the world planners in order to bring about world government. Whether or not this is true, it cannot be denied that both wars furthered their cause.²⁴

Founding of the United Nations

Shortly after the beginning of World War II the Council on Foreign Relations began pushing for a world-governing “peace” organization. As early as January 1942, our CFR controlled State Department instigated the 26 nations at war with the Axis nations to call themselves the United Nations.²⁵ It was at Moscow in 1943 that representatives of the United States, United Kingdom, Soviet Union, and China agreed to establish a “United Nations” type organization as soon as possible.²⁶

The CFR dominated the United States delegation to the United Nations founding in San Francisco. In addition, State Department official Alger Hiss, a CFR member and a secret Soviet agent, was made the secretary-general of the

conference. There were other high level American delegates who were communist agents. Among those was Harry Dexter White, who as an Assistant Secretary of the Treasury, in July 1944, headed the U.S. delegation to the Bretton Woods Conference. That conference established the International Monetary Fund and the World Bank. The United Nations was finally established on 26 July 1945, in San Francisco, with communist agent Alger Hiss as its first Secretary-General.²⁷

Bretton Woods Conference

Another wartime effort of the CFR was the Bretton Woods Conference held in July of 1944. According to publisher and commentator Dan Smoot, the Bretton Woods Conference set policies that our government has followed ever since, with the purpose of accomplishing four major objectives:

1. Strip the United States of its monetary gold reserve by giving the gold to other nations;
2. Build the industrial capacity of other nations, at our expense, to eliminate American productive superiority;
3. Take world markets — and much of the American domestic market — away from American producers to stop American domination of world trade.
4. Entwine American affairs with those of other nations until the United States could not have an independent policy, but would become an interdependent link in a worldwide socialist chain.²⁸

Once precious metal was removed as a backing for our currency, inflation became an institution and nations burdened under impossible debt became beholden to international bankers. In a gigantic wealth redistribution scheme, the Bretton Woods institutions (International Monetary Fund and the World Bank) are today draining the nations with lowest inflation to support the nations with highest inflation.²⁹ In the short period from Bretton Woods (1944) until 1975, the United States went from a country with the world's largest gold stock, with a standard of living the envy of the world — to a country defeated by a third rate power (Viet Nam), facing moral decline, inflation, self doubts, half its gold stock depleted, and short term debt to foreigners totaling nearly ten times the value of the remaining gold. This was just the beginning of our slide towards world feudalism.³⁰ By virtue of our huge debt, the balance of power is today being shifted from the United States to Europe.³¹

The International Monetary Fund and The World Bank

These are the key brainchildren of the Bretton Woods Conference. The International Monetary Fund was established to control international exchange rates and to “stabilize currencies,” but in reality is a framework for a central bank of issue. Once the “bank of issue” part is accomplished (issuance of an international currency) world government will

be an established fact.³² In the 1980's, the IMF took on the roles of managing and financing the rescheduling of international debt and arranging loans to third world countries. The IMF is funded by its member states and, in effect, perpetrates a Marxist-Leninist redistribution of wealth scheme.³³

The World Bank was established to help postwar reconstruction and development as an international lending agency, but it mostly lends U.S. dollars from U.S. taxpayers.³⁴ It was Senator Jesse Helms, in 1987, who stated the intentions of the international bankers best:

[I]t is no secret that the international bankers profiteer from sovereign state debt. The New York banks have found important profit centers in the lending to countries plunged into debt by Socialist regimes. Under Socialist regimes, countries go deeper and deeper into debt because socialism as an economic system does not work. International bankers are sophisticated enough to understand this phenomenon and they are sophisticated enough to profit from it.

Because the public debt is sovereign debt, the bankers have calculated that they will always be able to collect. If there is too much risk in the private debt side, it is a simple matter to get Socialist governments to nationalize banks, industrial enterprises, and agricultural holdings. In this way, private debt is converted to sovereign state debt which the bankers have believed will always be collectible.

The New York banks find the profit from the interest on this sovereign debt to be critical to their balance sheets. Up until very recently, this has been an essentially riskless game for the banks because the IMF and World Bank have stood ready to bail the banks out with our taxpayer's money.³⁵

The World Bank has been instrumental, through “white elephant” (funding unneeded, but politically correct) projects, causing many third world countries to go deeply in debt, so that today they are unable to build their needed schools, roads, hospitals, and other needed infrastructure.³⁶

Welfare

It was not until the twentieth century that welfare became a function of the state. The churches, private charities, and philanthropists filled this need in society. Government functioned with money provided for its limited programs through its customs, duties, tariffs, and taxes on goods. Taxes were levied on things, not the labor of people. A tax on labor creates serfdom. No income tax was levied on labor until the second decade of the twentieth century. It began with a voluntary tax in 1909, but this voluntary tax became a permanent tax as a result of World War I, providing a means for the government to confiscate the wealth of its citizens. It wasn't until Franklin D. Roosevelt, World War II, and the New Deal, that the government began to seriously

enter the realm of large scale social welfare (socialism), and to confiscate wealth from its citizens and give it to the government.

Today we work until July just to pay all local, state, and federal taxes before we earn one penny we can call our own. We have become bondservants to the federal government.³⁷ Jim Nelson Black observes:

In effect, we have become sharecroppers for the master in the White House. We are little more than indentured servants to a ruthless totalitarian regime that holds the power of intimidation, financial retaliation, and even imprisonment over our heads at every turn. The political, economic, and spiritual bondage from which our forefathers fled when they first came to America now enslaves the entire nation. We are bound by an onerous form of "taxation without representation" the founders of this nation would never have endured.³⁸

Initially, the main mechanism for creating this new economic order was the Bretton Woods Conference of July 1944, which laid the foundations for the postwar monetary system. Besides leading to creation of the World Bank and the International Monetary Fund (IMF), it redefined debt, credit, and government spending. Bretton Woods may well have been the real beginning of the new world order.³⁹

Deregulation

It was deregulation that gave birth to globalism. The Group of Seven (G7) nations determined to take "countries as well as business, banking, finance, manufacturing, communications, travel, consumer products, computers, technology, etc. and blending them into one – through mergers and acquisitions, and standardization." Prior to 1979, all economic and financial laws were written with the good of the country in mind. Beginning in 1980, with the passage of the Depository Institution Deregulation and Monetary Control Act all that changed. This allowed the banks to dictate the kind of interest they were going to pay. It allowed foreigners to invest in America. It also allowed the banks to pay 2 to 3 percent on your savings, while charging 15 to 21 percent for credit card debt.⁴⁰

Mergers and acquisitions

Mergers and acquisitions is the process that creates multinational or transnational corporations from once "national" corporations. Spurred on by deregulation, the new corporation no longer has national loyalties. The world is being conquered not by guns and bullets, but by mergers and acquisitions. No longer can the little "mom and pop" operation, or the "national" corporations survive; if you want a job you will march to the beat of the New World Order.⁴¹ In 1990, Malachi Martin had this to say about the birth of the New World Order in his book, *The Keys of This Blood*:

The father of this version of the new world order is to be the interdependence of nations. Its mother

is to be that particularly modern process called international development. It is to be midwived by the entrepreneur, the banker, the technocrat, the scientist and, ultimately, the lawyer. It is to be born between the printed sheets of compacts and agreements; joint ventures and mergers; contracts and covenants and international treaties signed and countersigned by the political bureaucrat, and sealed with the stamp of united nations.⁴²

The plan of the one-worlders includes the merger of many smaller national corporations into a small manageable number of very large multi-national corporations. International corporate mergers are currently accelerating at an unprecedented rate.⁴³

Standardization

"Standardization is the process of bringing the various laws of all the countries of the world into conformity with global goals," in order to create the necessary global infrastructure. The necessary step is that "all countries pass the same laws in the areas of accounting, banking, stock exchanges, delivery and settlement of investments, manufacturing, trade, etc. When completed, all industries worldwide will adhere to the same global rules. Eventually there will be one stock exchange for the entire world.⁴⁴

Environment

The issues of the environment have very little to do with the environment itself, but have more to do with population control. The ultimate goal is consolidation of power by creating regulations pertaining to land usage, air quality, and mineral use as eventual instruments of the future world government.⁴⁵

A World Without Borders

Since 1971, the world's monetary systems were allowed to "float" against each other, seeking their own value. This allows the central bankers the ability to manipulate the value of individual currencies by their monetary policies. At some point in time the worlds surviving currencies (probably the Euro, the Dollar, and the Yen) will reach parity, and become in effect a one-world currency. To do this the various regional currencies will need to first be merged. The Euro will be the currency of Europe. The dollar will survive in the Americas once the transfer of wealth is complete between the United States and the Latin countries of Central and South America. In Asia the same process will result in the survival of the Yen. At that point they will be merged.⁴⁶ Ultimately, the use of electronic money will replace the use of currency in the final stage.

The Monetary Control Act of 1980 tore down financial borders between countries. The laws of the United States and those of other nations, by agreement, are being changed in order to allow "blending together of economies, people, laws, politics, monies, and social ethics into one...", creating a world without borders. The North America Free Trade Agreement (NAFTA) is designed to tear down the borders with our neighbors and further adjusting the standard

of livings of all countries in the Americas to parity. The standard of living for all Americans has no place to go but down, thanks to the one-world planners.⁴⁷

North American Free Trade Agreement (NAFTA)

The North American Free Trade Agreement is not “free trade,” it is managed trade, more accurately, State Monopoly Capitalism designed to favor an elite group, benefiting Wall Street, while transforming “middle America” into a feudalistic underclass. It means tariff-free trade and open borders similar to the European Union. It will mean higher income for Mexican labor, with a corresponding lowering of standards for the American worker.⁴⁸

NAFTA has formed the United States, Canada, and Mexico into a managed trading bloc that is expected to be fully operational by 2005. This bloc will eventually be expanded to include both continents of North and South America, and will be renamed Free Trade Area of the Americas (FTAA). The economics of all the involved countries must first be aligned with the requisite reduction of standard of living of the United States and Canada by one-half. This will be accomplished by gradual de-industrialization of the northern regions (Canada and the United States, while industrializing the southern ones. This same plan is being implemented by Japan, Korea, Taiwan, and other countries of the Pacific Rim.⁴⁹ Once NAFTA becomes FTAA with the inclusion of Chile, Argentina, Brazil, and other Central and South American countries, the Secretariat controlling all trade is to be located in Texas. The other centers of control will be located in Brussels (EC) and Tokyo (Pacific Rim).⁵⁰

Look for continued efforts to unify North and South Korea, and Taiwan with China. The formation of three trading blocs of EC, FTAA, and the Pacific Rim may make China a dangerous outsider. Russia may join the EC, or go it alone and possibly form a fourth bloc with some former Iron Curtain nations. In any event, the economic war for control of the economic resources located in the Middle East, Siberia, and Africa will continue.⁵¹

The large trading blocs, that are created by the EC, NAFTA/FTAA, eventually the Pacific Rim countries, and finally some form of Russia with a number of her former partners, will be more manageable by a world government.⁵² One must puzzle over the allegiance of “conservatives” like of Rush Limbaugh and Pat Robertson, in the one-world scheme, when they openly promoted passage of NAFTA on their respective radio and television programs.

We are seeing the tearing down of borders and we are seeing that world courts are forming with their own laws. They will eventually be given jurisdiction over peoples of formerly sovereign nations. The treaties signed by our very leaders will supersede our “Bill of Rights”.

Lest anyone be lulled into the belief that the change of administration from Democrat Bill Clinton to Republican George W. Bush will halt the march toward the new world order should look again. President George W. Bush’s selection of Robert B. Zoellick as U.S. Trade representative indicates business as usual when it comes to NAFTA and

World Trade Organization style “free trade.” Mr. Zoellick was the key official working on NAFTA during the first Bush administration. Globalism is alive and well in this Republican administration.⁵³

Military

The control of the world’s military can be seen best in the attempt at transferring the armaments and military personnel of the world’s nations to the United Nation’s “Peace Keeping Forces.” This has been a three-stage program that has been on-going since the Kennedy administration. It is documented in *Freedom From War*, also known as *Department of State Publication 7277*. This plan calls for disarming individual nations, particularly the United States and Russia, and arming the United Nations to the point that no individual nation can challenge the might of the United Nation’s forces. This program appears well under way for completion when the rest of the one-world plan is finalized.⁵⁴

Religion

All the parts are coming together for world government, but none of this will mean much unless the world planners can control the religious area of men’s lives. You cannot very well bring men together as global citizens, unless they can agree as one, both politically and spiritually. There is a plan for this as well. That plan is well underway, and will be addressed in the next part. **AQ**

Part 6 The Final Religion

And there came one of the seven angels which had the seven vials, and talked with me, saying unto me, Come hither; I will shew unto thee the judgment of the great whore that sitteth upon many waters: With whom the kings of the earth have committed fornication, and the inhabitants of the earth have been made drunk with the wine of her fornication. So he carried me away in the spirit into the wilderness: and I saw a woman sit upon a scarlet coloured beast, full of names of blasphemy, having seven heads and ten horns.... And he saith unto me, The waters which thou sawest, where the whore sitteth, are peoples, and multitudes, and nations, and tongues. Revelation 17:1-3, 15

The Harlot

The "Harlot" represents false religion. Jeremiah chapter 3 indicates that in times past Israel played the harlot. She went after false gods. "Waters" refers to peoples, nations, races and languages. The harlot has such influence over masses of people that she has been able to control entire nations. We could be speaking of religious systems such as Secular Humanism, Papal Rome, or both? The woman therefore represents a spiritual or religious witness. When we speak of the Bride of Christ we see that the woman is also a symbol representing the Church. This reinforces the interpretation of the woman representing a spiritual or religious witness. Therefore the symbol for the end-time "church" is a woman. The woman of Revelation chapter 21, the Bride of Christ, represents a spiritual religious notion, a church assembly, and many saved people. Therefore the woman of Revelation 17 represents a religious movement.¹ The woman of chapter 17 is a whore. The woman is the personification of false religion. There are two types of fornication, physical and spiritual. These verses refer to spiritual fornication. Because she is a **great** whore, the religious movement is large. This large religious movement is spread into many nations and languages. In Revelation 17:2 and 3, the harlot has committed spiritual fornication with the kings and emperors of the world through her false religion. That religion ruled the lives of the people.² That she rides the beast indicates that her false religion dominates the civil power. The beast (Antichrist) is the same as that of Revelation chapter 13. The beast represents the final empire. The character of this empire is totally blasphemous, and its scarlet color signifies that it is sinful and bloodthirsty beyond belief.³ The woman represents the final world religion, a universal state religion.

World Religion

The Christian religion, or "Christianity," began with Jesus Christ at the start of His public ministry about 30 AD.

Christianity sprang from within the bounds of the Roman Empire. The official established religion of the empire was pagan, a religion of many gods. This religion was established by law, and supported by government. Christianity, on the other hand, was to be individual, personal, and purely voluntary. Converts were made by persuasion, not physical or governmental compulsion. Christianity multiplied and spread rapidly, establishing individual churches throughout the empire. During the first few hundred years, many of the bishops, or pastors, began to assume authority over other smaller churches. This authority went beyond what the New Testament provided.⁴

It wasn't long before the pagan, and Jewish, idea of ceremonials as necessary for salvation began to creep into the young church. By the year 370 AD, the idea that baptism was essential for salvation (Baptismal Regeneration) began the practice of infant baptism, with sprinkling instead of immersion. Constantine, while embracing Christianity, adopted the erroneous doctrine of Baptismal Regeneration, believing that his sins would be washed away, delayed his own baptism until just before his death. These changes took place slowly over time, so that by 251 AD some churches separated from churches that deviated from the practices laid down during apostolic times. It was during the first three centuries that changes in church government and doctrines, such as Baptismal Regeneration began to diverge from the teachings of the New Testament.⁵

Pagan Rome subjected the early church to much persecution until 313 AD, when the Roman Emperor Constantine brought about a merger of the temporal power of Rome with the Christian religion. At this time a hierarchy was formed at a council called by Constantine in 313 AD. By merging the temporal power of Rome with the spiritual power of Christianity, the world could be easily conquered. Christianity, given the power of the state, would become a one-world religion, just as the Roman Empire would become a one-world empire.⁶

With the hierarchical church came a new form of persecution, that of persecuting other Christians that chose to forsake the church-state merger, remaining loyal to the original form of Christianity. The hierarchical form of Christianity began to depart from the authority of the Scriptures, and depended on its own tradition, Church Fathers, and decrees as being equal with the Scriptures. By this departure, the Church could do and proclaim whatever it decided apart from Scripture. This would later result in the Catholic doctrine of "Papal Infallibility." By this doctrine, the Pope could now proclaim anything he wished regarding matters of faith and morals, without regards to the Scriptures. This is the reason that there can be no satisfactory debate between Catholics and Protestants. Catholics do not obtain their sole authority from the Scriptures.⁷ There can be no debate when one side can appeal to "facts" of his own making.

Many early Christian churches refused the call for the marriage of church and state that would later appear in the fourth century. This was the same idea that the Baptists and other churches would return to. Many of these early Christian groups never at any time entered the hierarchy of

the Catholic denomination. Particular note should be made of the fact that Christian churches have existed in a continuous line from apostolic times, separate from that of the Catholic Church.⁸ These churches were never a part of the Catholic Church, and therefore did not break from it.

Donatists, Paulicians, Albigenses, and Ancient Waldenses are examples of churches that developed separately from the Catholic Church from apostolic, or near apostolic, times, and are not "protestant" in the sense that they were part of the Catholic Church at one time. Others separated in the early centuries. Some were unjustly accused of being Manicheans, even though their remaining records do not support that claim. The point to be made is that these churches can trace their history, directly or through associations, separately from the Catholic Church, to apostolic times, and that an attempt at a first century type of Christianity has been maintained throughout New Testament history. The idea of "apostolic succession" from Peter to John Paul II cannot be sustained. The name "Ana-Baptist" can be traced back to the third century AD, as representative of those Christians opposed to infant baptism, although they are not the same as those known as Ana-Baptists from the sixteenth century.⁹

These separate churches have been severely persecuted by the established Catholic Church, as well as the established Protestant Church (e.g. Episcopal, Presbyterian, and Lutheran). Throughout history, established churches in the various countries sought to exclude all others. Bitter persecutions of these excluded churches persisted until certain agreements, or toleration acts were signed between denominations, pledging to leave each other alone. Such is the agreement between Catholics, Lutherans, and Presbyterians, in 1648, known as the "Peace of Westphalia." This agreement did not prevent these same churches from persecuting all others.¹⁰ A modern form of the "Peace of Westphalia" has emerged in the last few years known as "Evangelicals and Catholics Together." Like the "Peace of Westphalia," this document promotes tolerance between Evangelicals and Catholics. In the meantime, the Catholic Pope, in reaching out and embracing all religions of the world in tolerance; while doing so, giving the impression that they are considered legitimate paths to God, is promoting the spirit of ecumenism. It is just this spirit of ecumenism that is leading the hearts and minds of the world's people to eventually merge their beliefs into what will be known as the final world religion. Eventually, persecution will be great for those who choose not to follow.

Blurring the Lines of Distinction

In order to pervert our souls, to make us willing accomplices, we will be given a new religion, comprised of a forging of alliances with the various religions of the world. This new religion will be one of ecumenism, tolerance, political correctness, and most likely, one influenced by environmentalism. We will be one with nature (our mother). Mikhail Gorbachev, an atheist turned pantheist, framed the so called "Earth Charter," intended to fuse socialism and mysticism into a UN-approved new world religion.¹¹

Gorbachev has written about his relationship with Pope John Paul II, and their mutual plan for a new world:

I have carried on an extensive correspondence with Pope John Paul II since we met at the Vatican in December, 1989... we share a desire to move forward and complete what we began together.... What I always held in high esteem about the Pope's thinking and ideas is their **spiritual content**, their striving to foster the development of a **new world civilization**....

Now it can be said that everything which took place in Eastern Europe in recent years [the demise of Communism] would have been impossible without the Pope's efforts and enormous role, including the **political role**, which he played in the world arena.¹²

According to a June 1999 article in the newsletter, *Berean Call*, by Dave Hunt, our public form of Christianity has become a "humanistic 'Christianity.'" We are

attempting not to convert the world, but to get the world to accept our morality. We prefer to heal the world's institutions rather than save souls. This can best be seen in our ready support for the **National Day of Prayer**, when everyone is urged to join in prayer to **whatever god they might believe in**. Prayer breakfasts often welcome Hindus, Buddhists, Muslims, and Atheists. The speakers at such gatherings often offer a watered down message to appeal to everyone. We are admonished that we say nothing that might offend our brothers and sisters from other persuasions. Read the Gospels! In particular, read Matthew chapter 23. Jesus was not careful to avoid offending the "blind guides" of His day. The ecumenical message of today leads the hearer to assume that sin is not our problem, and that God's sole purpose is to make us happy and successful.¹³ Many seek out churches that preach love from the pulpit; no mention of a literal hell is heard. The circus atmosphere of the "electronic church," where the message is "Let me entertain you," lures many thousands. The gospel has taken on the slick glossy cover of a "Madison Avenue" sales promotion, while P. T. Barnum shouts from his electronic pulpit, "There's a sucker born every minute." The antics of the electronic church, Benny Hinn, and others are plain to see, but the activities and aberrant pronouncements of some of our most respected religious leaders are those that may subtly lead us, as sheep, down the path to the final religion.

Our spiritual giants are at the forefront of promoting activities such as the National Day of Prayer and prayer breakfasts - Billy Graham, Bill Bright, Dr. James Dobson, and others.¹⁴ This may be admirable, but are they also engaging in the ecumenical spirit of the times? One must wonder about what form of Christianity Billy Graham was

espousing when he stated in an interview that **environmentalism is a much more important issue than preventing abortions**.¹⁵ Our popular religious leaders seem to be espousing the same politically correct rhetoric as our environmentally conscious political leaders, such as Mikhail Gorbachev and Al Gore, who proclaim in their own way that "Gaia" is god.¹⁶ Gary Hedrick warns:

When Christianity is popular with the masses, then it's time to examine this brand of Christianity to which the world does not object, because they certainly objected to Jesus.¹⁷

Sadly, in his book, *Occult Invasion*, Dave Hunt expresses concern over the public statements of some of our most revered and respected Christian leaders. At the 1986 Amsterdam convention sponsored by the Billy Graham Evangelistic Association, Leighton Ford proclaimed that we should, "Preach the gospel but don't be so negative as to refuse to endorse or work with those who belong to a group that proclaims

a different gospel." The late Mother Teresa considered Buddhism, Hinduism, Islam, and other religions to be acceptable ways to God. It appears that she cared for their bodies while neglecting their souls.¹⁸ Billy Graham, in a televised interview on Robert Schuller's *Hour of Power*, has said much the same thing in stating his belief that those following other paths may be saved. In this interview Graham was asked if it were possible that people born in darkness, never to be exposed to the Bible, might be saved? He responded:

Yes, it is, because I believe that. I've met people in various parts of the world in tribal situations that never have seen a Bible or heard about a Bible, and never heard of Jesus, but they've believed in their hearts that there was a God, and they've tried to live a life that was quite apart from the surrounding community in which they lived.¹⁹

Billy Graham reiterated this position, somewhat less distinctly, in another interview for *Parade* magazine when he said, "I fully adhere to the fundamental tenets of Christian faith for myself and my ministry. But, as an American, I respect other paths to God—and, as a Christian, I am called on to love them."²⁰ Despite a recent (2001) embarrassed Email retraction from the Billy Graham Evangelistic Association, of the Schuller program remarks, Billy Graham made a similar statement in an article in *McCall's* magazine in 1978.

I used to think that pagans in far-off countries were lost — were going to hell — if they did not have

the Gospel of Jesus Christ preached to them. I no longer believe that... I believe there are other ways of recognizing the existence of God — through nature, for instance — and plenty of other opportunities, therefore, of saying yes to God.²¹

Dave Hunt calls Billy Graham's ecumenism disturbing, citing his unremitting support of the late Dr. Norman Vincent Peale, who has said that Jesus Christ is "one of the ways, God is everywhere," and that, he "found eternal peace in a Shinto shrine." Hunt also found disturbing Graham's implied approval of Mormonism in an interview with Larry King. In the same interview, Larry King gave Graham 30 seconds to say anything he wished to his audience. Dave Hunt relates that Graham's message contained "No Christ, no cross, no gospel."²² Dave Hunt points out that when Billy Graham was given an opportunity by Robert Schuller to witness to an estimated television audience of 20 million viewers, believed to include hundreds of Rabbis and over a million Muslims, Graham delivered a watered down ecumenical message, again containing "No Christ, no cross, and no gospel."²³ Billy Graham's prayer delivered at the May 2001 National Day of Prayer again contains "no Christ, no cross, and no gospel." Finally, Dave Hunt relates the disturbing words of a New Zealand Christian who committed his life to Christ at a 1957 Billy Graham crusade, where a "clear preaching of the gospel of Jesus Christ" was heard; but his experience of attending and working in the Billy Graham 1985 evangelistic campaign in Sidney was far different as shown by his words:

A lot of what I saw, heard and read during that time contradicted what I had experienced in 1957! Something had changed.... The Billy Graham Evangelistic Association had become "politically correct." It was now the friend of politicians and governments worldwide, and a welcome guest at the Vatican! Further investigation proved depressing and alarming.... The decline from Evangelical orthodoxy to ecumenical apostasy has taken a mere 40 years.... Sad to say, my journey into my spiritual past left me with a heaviness and concern for the future....²⁴

To further the cause of blurring the lines of distinction between religions, Chuck Colson and Bill Bright, both recipients of the Templeton Award that is awarded to those promoting unity among the world religions (Billy Graham has also received this award), together with J. I. Packer and Pat Robertson, have championed the cause of evangelical and Catholic unity with the document, *Evangelicals and Catholics Together*, that promotes togetherness, while ignoring or rationalizing the vast differences that many in the past died defending.²⁵ *The Berean Call* of February 2001, reports that Dr. James Dobson and Chuck Colson visited the Vatican in November 2000 for a three-day conference on the world economy's impact on families. They also met briefly with the Pope. *The Berean Call* asks the question, "[In view of

the centuries old differences between Catholics and Protestants], what exactly are Colson and Dobson advancing by their participation."²⁶ Again, for the sake of the recent push for evangelical and Catholic unity, we see another blurring of distinctions, bit by bit. I would not want to seem to denigrate the good that men, such as Billy Graham, Chuck Colson, J. I. Packer, Leighton Ford, Bill Bright, Pat Robertson, and others have otherwise done, but only to point out that they seem to have been caught up in the current wave of political correctness in their public activities and pronouncements. We are admonished, "Do not touch God's anointed." But, we should never place our leaders out of reach of accountability for what they say or do. It seems that if we call men such as Billy Graham to account, people get upset. Error and compromise should be exposed no matter who says, or promotes it.

On 23 June 1997, the cause of world religion was furthered when 200 delegates from the world's various religions met at Stanford University to lay plans for the establishment of the "United Nations of Religion," to promote respect for each religion's distinctiveness. Whatever happened to the Great Commission? This blurring of distinction carries over to the Promise Keepers, when they brought together 39,000 clergy at Atlanta for the purpose of bringing down denominational barriers between Protestants, Mormons, and Catholics. How can this be? The Mormons don't even believe in the same Jesus. The call for bringing America back to "traditional moral values" has united evangelicals, Catholics, Mormons, and Moonies to "Christianize America."²⁷ Somehow the fundamental differences are being sacrificed for the sake of morality, instead of the salvation of souls. All of this is leading to a blending of religions that I believe will result in the final one-world religion. It is the same blending that occurred under Constantine, when paganism blended with Christianity. It seems that the prevalent feeling is that the world and America can be saved by a compromised ecumenical gospel. Llewellyn Rockwell states it best:

Christianity is now thoroughly politicized. The [Catholic] bishops and [Ralph] Reed have no trouble speaking about the importance of pro-family legislation, or the glories of religious pluralism, but they are shy about such basics as the Christian teaching of salvation. The longer the process of politicization continues, the thinner the faith gets. Political ambition causes people to water down their beliefs for the sake of gaining favor.... The first stage of sell-out comes with the exaltation of political pluralism above doctrinal truth, the second stage with the denial of doctrinal truth altogether for achieving political goals.²⁸

Nimrod founded Babylon, the cradle of civilization, on the shores of the Euphrates River, in what is now modern Iraq. Nimrod was in rebellion against God. Like a moneychanger, he formed cities, for commercial and social purposes, contrary to God's command in Genesis 8:17 to "be fruitful and multiply upon the earth." From Babylon, self-

government originated apart from God, and false religion was established in defiance of God's will. This rebellion of government and religion has continued to the present time, and has enslaved men in superstitious darkness.²⁹

Movement Towards Unity

Even before the 1997 meeting at Stanford University, a World Parliament of Religions met in Chicago, Illinois in 1993, and recommended a spiritual cooperation. The intention, even then, was to set up a separate "United Nations of Religion," on an equal footing with the political United Nations, to speak for all faiths.³⁰ Those attending included Catholics and Protestants, Pagan, Eastern and other religions. The Pope himself has met with spiritual leaders of all religions, Eastern, Muslim, Indian Witch Doctors, among others and proclaimed that we all worship the same God. Protestant and Catholics have signed the previously mentioned document called *Evangelicals And Catholics Together*, furthering ecumenism.³¹ It appears that we are entering a new age of spiritual compromise leading to a melding of doctrines for a final religious system. Tim LaHaye observes:

This unity movement should not, however, be limited to apostate Christianity. We can expect to see it move toward amalgamating all religions of the world under Rome's headship because our text states that the religious system at the end time will be a one-world religion: "where the harlot sitteth, are peoples, and multitudes, and nations, and tongues ([Rev 17] v.15). This can only mean a one-world religious system."³²

In India we find that Hinduism is so parallel to the practices of Romanism that many of the Hindus can become Roman Catholics and need not give up Hinduism. Since the religions of the world all have idolatry in common, it would be a simple thing for them to amalgamate on a common basis. What do they care whether they are worshipping Semiramis and Tammuz or Mary and Jesus, just so they have an idol before which to bow down.³³

In September 2000, the United Nations held a "Millennial Summit," bringing together the world's leaders to set the course for the new millennium, and to attempt to convince all nations to implement many of the treaties still on the books of the UN. At the same time, religious leaders, Mikhail Gorbachev among them, met to promote harmonization and integration among the religions of the world. The final results of such integration may bring about the final form of the one-world religion of the "harlot."

The Future is Now

The Bible speaks of a time when the world attempted to be one. That was the world of Nimrod and the Tower of Babel. Interestingly, the European Union has chosen the Tower of Babel as the symbol of their new order. It was

Nimrod who defied God at Babel, and the people were scattered.

The Bible also speaks of another time when proud men will once more shake their fist at God and attempt a final world order. We are told in Revelation chapter 13 and 14, that it will be a time when the Antichrist will require men to worship him, and will withhold the necessities of life from those that do not heed his command to take his "mark." No one will be permitted to buy or sell unless they take the "mark of the beast."

We are living in a time when all men can be numbered. The technology exists to place a computer chip under the skin for the purposes of identification, and for use as a money device. This technology is being sold, at first, as tracking devices for animals, and for children as a kidnap deterrent. It does not take too much imagination to determine what other ways might be found for its use.

There will be world government, but it will not stand. According to Daniel, the eternal Kingdom of God will ultimately defeat it during the Great Tribulation (Daniel 2:41-44). We live in a time when our nation is ripe for a merger into a global government. We are experiencing national decay, and unless corrected, we will fall or be subjugated. We are indeed a culture in crisis.

Awareness and Saving Grace

As Christians we need to be aware of what is happening around us. We should beware of spiritual leaders that seem to always be in the limelight, and whom the media loves to love. Be careful that you do not follow blindly after a man, but put your faith in the one true God who will never let you down. Men fail, God does not. Always check out the "truth" that man says by searching the "Truth" of the Scriptures. Pray for the men that have been mentioned in this article. If they are compromising God's Word in their lives, ask God to show them the way back to the uncompromised gospel of Jesus Christ. Jesus spoke of religious compromise and tyranny in Matthew chapter 23. The Scribes and Pharisees were obsessed with legalism, the Sadducees denied the supernatural, and The Herodians were practicing worldliness.

But woe unto you, scribes and Pharisees, hypocrites! for **ye shut up the kingdom of heaven against men**: for ye neither go in yourselves, neither suffer ye them that are entering to go in. Woe unto you, scribes and Pharisees, hypocrites! for **ye devour widows' houses, and for a pretence make long prayer**: therefore ye shall receive the greater damnation. Woe unto you, scribes and Pharisees, hypocrites! for **ye compass sea and land to make one proselyte, and when he is made, ye make him twofold more the child of hell than yourselves**. Woe unto you, ye blind guides, which say, Whosoever shall swear by the temple, it is nothing; but whosoever shall swear by the gold of the temple, he is a debtor!.... Woe unto you, scribes and

Pharisees, hypocrites! for **ye pay tithes of mint and anise and cummin, and have omitted the weightier matters of the law, judgment, mercy, and faith:** these ought ye to have done, and not to leave the other undone. Ye blind guides, which strain at a gnat, and swallow a camel. Woe unto you, scribes and Pharisees, hypocrites! for **ye make clean the outside of the cup and of the platter, but within they are full of extortion and excess.** Matthew 23:13-16, 23-25

The same day came to him **the Sadducees**, which say that **there is no resurrection**, and asked him... Jesus answered and said unto them, Ye do err, not knowing the scriptures, nor the power of God. Matthew 22:23, 29

And **the Pharisees** went forth, and straightway took counsel with **the Herodians** against him, how they might destroy him. Mark 3:6

This is a fit description of our secular society today, as a corrupting influence, tugging at our children's values. We must not forget that our ultimate hope is in the saving grace of God Almighty, and the Blood of Jesus Christ His Son, our Lord. If you have not yet accepted Jesus Christ as your Lord, you are challenged to read for yourself the saving words of Jesus Christ by reading the book of John. Know this, you cannot save yourself. Your salvation was provided on a wooden cross 2000 years ago at Jerusalem. That salvation is a gift freely given (Ephesians 2:8, 9). In order to accept that free gift we only need to repent and confess our sins, and acknowledge verbally that Jesus is our Lord who was raised from the dead (Romans 3:23, 6:23, 10:9-13, 1 John 1:9, 10). The time is now. There is a time coming when it will be too late. The time is coming when the Antichrist will rule, and then there will be great tribulation. Those that remain will suffer great hardships, but must be steadfast to the end in order to be saved. Those that accept Him now will avoid the great wrath of God that will come during the time of the Antichrist and the Great Tribulation.
